We are delighted to announce that several of our clients have been awarded grants through the first Grid Resilience and Innovation Program (GRIP) round under the Department of Energy. We also assisted clients earlier this year in applying for the second GRIP round, which had \$3.9B in available funding for Fiscal Years 2024 and 2025. In addition, we worked closely with several clients across the nation last year on the Letter of Interest for the New Empowering Rural America (ERA) Program (\$9.67B available funding) offered by the USDA/Rural Utilities Services.
